Definitions

AED or Dirham is the lawful currency of the UAE.

Departing Passengers means all passengers on board a departing aircraft. This includes transit passengers, transfer passengers, infants (under the age of 2) and positioning crew, but excludes aircraft operating crew.

Embarking Passengers means all passengers on board a departing aircraft. This includes transit passengers, transfer passengers, infants (under the age of 2) and positioning crew, but excludes aircraft operating crew.

Infant means a child under two years of age who has not paid to occupy a seat on an aircraft.

MTOW means for an aircraft its certified maximum take-off weight as specified by the manufacturer or as approved by the General Civil Aviation Authority.

Operating Crew means any of the Operator's personnel operating as flight deck or cabin crew on an arriving or departing aircraft.

Positioning Crew means your flight and cabin crew, other than Operating Crew, arriving into, or departing from, the Airport on company duty travel for the purpose of positioning for, or returning from, crewing duties.

Transfer Passenger means a passenger who connects from one international flight to another without being processed by the Abu Dhabi Immigration Service at the Airport within 24 hours from arrival.

Transit Passenger means a passenger continuing travel with the same arrival and departure flight numbers within 24 hours from arrival.

Passenger Service Charge (PSC)

A passenger service charge will be levied to an outbound airline on all fixed and rotary wing passenger aircraft embarking passengers through Zayed International Airport.

TYPE OF PASSENGER	CHARGES (AED/PAX, excl. VAT)
International Departing Passenger originating in Abu Dhabi	75.00

EXEMPTIONS

1. Infants.
2. International Transfer Passenger (continuing travel within 24 hours from arrival).
3. International Transit Passenger (continuing travel with the same arrival and departure flight numbers within 24 hours from arrival).
4. Aircraft Operating Crew.

Passenger Facility Charge (PFC)

A passenger facility charge will be levied to an outbound airline on all fixed and rotary wing passenger aircraft embarking passengers through any international airport of the Emirate of Abu Dhabi.

TYPE OF PASSENGER	CHARGES (AED/PAX, excl. VAT)
International Departing Passenger originating in Abu Dhabi	40.00
International Departing Passenger transferring in Abu Dhabi to another flight on the same airline or other airline	40.00

Note: Effective for first travel date on or after 24 January 2024 for travel as per the below table, the Passenger Facilities Charge will be amended as follows:

EXEMPTIONS

1. Infants.
2. International Transit Passenger (continuing travel with the same arrival and departure flight numbers withing 24 hours from arrival).
3. Aircraft Operating Crew.

Aircraft Landing Charge

For each fixed wing and rotary aircraft, a charge will be levied per runway landing for passenger, cargo and general aviation operations, as follows:

AIRCRAFT CERTIFIED MAXIMUM TAKE-OFF WEIGHT MTOW (IN KG)	CHARGES (AED/PAX, excl. VAT)
Up to 5,000 kg	AED 4.85 per 500 kg, or part thereof
Exceeding 5,000 kg, but not exceeding 50,000 kg	AED 6.00 per 500 kg, or part thereof
Exceeding 50,000 kg	AED 7.35 per 500 kg, or part thereof

EXEMPTIONS

The following aircraft are exempted from landing and parking charges:

1. Royal, diplomatic and state aircraft
2. Aircraft engaged in search and rescue operation
3. Bona fide test flights or calibration flights approved by the airport authority

The Operator remains responsible to provide the Airport Operation Control Centre (AOCC) with all relevant documents about such movements including a copy of the diplomatic clearance in advance to TrafficOfficer@adairports.ae and billing@adairports.ae prior to operation.

Diverted Flights are not exempted from Airport Charges. All relevant Airport Charges are applicable as set out in the Schedule of Aeronautical Charges.

Aircraft Parking Charge

No aircraft whatsoever shall be permitted to be parked for a period of more than 4 hours (6 hours for cargo flights) without ADA's prior written consent (including for extended technical delays/up-line delays). Any abuse of parking arrangements may result in future use of the airport being withdrawn by ADA.

These charges will apply whilst the aircraft is parked on the areas designated as Airport parking areas within the passenger and/or cargo operations areas. Parking charges will be based on the total number of hours or part thereof that an aircraft has been parked on areas designated as the airport parking areas. Parking times will be measured from On-block time to Off-block time.

Passenger Operations

Up to 1.5 hours	FREE
Additional hour between 1.5 and 2.5 hours, or part of thereof	200
Every additional hour, after 2.5 hours, or part of thereof	330
Wide Body	
Up to 3.0 hours	FREE
Every additional hour between 3.0 hours and 6.0 hours, or part of thereof	300
Every additional hour after 6.0 hours, or part of thereof	560

Cargo Operations

AIRCRAFT TYPE / PARKING DURATION	CHARGES (AED/HOUR, excl. VAT)
Narrow Body	
Up to 6.0 hours	FREE
Additional hour between 6.0 hours and 7.0 hours, or part of thereof	200
Every additional hour after 7.0 hours, or part of thereof	330
Wide Body	
Up to 6.0 hours	FREE
Every additional hour between 6.0 hours and 9.0 hours, or part of thereof	300
Every additional hour after 9.0 hours, or part of thereof	560

General Aviation

For each aircraft parked at the airport within the General Aviation area, a charge calculated using the product of the length of the aircraft times the span of the aircraft, in meters, times the following charges:

PARKING DURATION / BASIS OF CALCULATION	CHARGES (AED/HOUR, excl. VAT)
Up to 6.0 hours	FREE
For every additional 24-hour period, or part of thereof that passes:	
For the first 50 m ² (length x wingspan)	3.00
For each additional 10m ² (length x wingspan), or part thereof	0.60

General Aviation aircraft parking outside of designated Airport parking within the General Aviation areas for General Aviation Aircraft will be subject to charges specified under **Aircraft Parking Charge, Passenger Operations**.

Passenger Security & Safety Fee (PSSF)

A passenger security and safety fee will be levied to an outbound airline on all fixed and rotary wing passenger aircraft embarking passengers through Zayed International Airport.

TYPE OF PASSENGER	CHARGES (AED/PAX, excl. VAT)
Departing passenger originating in Abu Dhabi	5.00

EXEMPTIONS

1. Infants
2. Transfer Passengers (continuing travel within 24 hours from arrival).
3. Transit Passengers (continuing travel with the same arrival and departure flight numbers within 24 hours from arrival).
4. Aircraft Operating Crew.
5. Positioning Crew.

Advance Passenger Information Fee (API)

An advance passenger information fee will be charged for each arriving passenger, departing passenger and transit or transfer passenger continuing his/her journey on the same or any other airline.

TYPE OF PASSENGER	CHARGES (AED/PAX, excl. VAT)
International arriving passenger	5.00
International departing passenger originating in Abu Dhabi	5.00
International departing passenger transferring in Abu Dhabi to another flight on the same airline or other airline	5.00
International transit passenger continuing travel with the same arrival and departure flight numbers within 24 hours from arrival	5.00

EXEMPTIONS

1. Infants
2. Aircraft Operating Crew.

Common Use Terminal Equipment Fee (CUTE)

A common use terminal equipment fee will be charged for all departing passengers.

All departing passengers (total onboard)	6.00
